TEMPORARY RESTRAINING ORDER**



COMES NOW Plaintiffs, by and through undersigned counsel, and hereby respectfully request an emergency hearing on March 20, 2023, on their *Motion for Temporary Restraining*

*Order* enjoining HB 152, which was passed by the legislature and sent to the Governor on March 3, 2023, and anticipated to be codified as Wyo. Stat. § 35-6-120 *et seq.* Plaintiffs anticipate HB 152 will become law with immediate effect if not vetoed by the Governor on or before March 18, 2023, at 11:59 p.m. Given that HB 152 infringes on Plaintiffs' fundamental rights under the Wyoming constitution, Plaintiffs request that the Court set an emergency hearing without delay. Counsel for Defendants have been made aware of this request for emergency hearing.

A proposed Order is attached hereto for the Court's consideration.
